

Local Smoking Restrictions Tougher Than the Colorado Clean Indoor Air Act

Local laws providing greater protection from secondhand tobacco smoke and emissions from electronic smoking devices.

The [2019 Colorado Clean Indoor Air Act](#) (CCIAA) prohibits the use of tobacco, electronic smoking devices, and marijuana in most public places and workplaces with certain exemptions.

Exempted or not Required by the CCIAA

Cigar or tobacco bar smoking prohibited (20)

- Arvada - Avon - Boulder County - Eagle County - Edgewater - Fort Collins - Frisco - Greeley - Louisville - Pitkin County - Pueblo - Salida - San Luis - Snowmass Village - Steamboat Springs - Summit County - Telluride - Timnath - Wheat Ridge (hookah) - Winter Park

Non-retaliation clause (19)

- Arvada - Avon - Breckenridge - Brighton - Carbondale - Eagle County - Fort Collins - Grand Junction - Littleton - Parker - Pitkin County - Pueblo - San Luis - Steamboat Springs - Telluride - Timnath - Vail - Westminster - Winter Park

Tobacco stores (8)

Outdoor Restrictions

*An * is placed after any community that prohibits the use of electronic smoking devices in an outdoor place.*

Perimeter areas of 25 feet that cover areas other than the entrance of a building (10)
