RESOLUTION AMENDING RESOLUTION 99-03 AND PROHIBITING SMOKING, INCLUDING SMOKING OF TOBACCO AND VAPING OF ANY SUBSTANCE IN ALL COUNTY OWNED BUILDINGS AND VEHICLES

WHEREAS, second-hand smoke has been determined to cause or significantly contribute to a number of serious health problems; and

WHEREAS, the Board of County Commissioners of the County of Gilpin have authority by statute to regulate the use and occupancy of all county owned buildings and vehicles, and

WHEREAS, the Board of County Commissioners has heretofore taken action to regulate smoking and vaping in all county owned buildings and vehicles, and

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that

- 1. smoking, including smoking of tobacco and vaping of any substance in all county owned buildings and vehicles or on county owned property except in designated areas (see Exhibit "A") is hereby prohibited; and
- 2. designated smoking areas shall be a minimum of 15 feet from any county building; and
- 3. "No Smoking or Vaping" signs shall be prominently posted on the front of all county buildings informing all employees, as well as, members of the public, of such prohibition.

DESIGNATED SMOKING/VAPING AREAS FOR GILPIN COUNTY BUILDINGS

Apex	Across from main entrance and south about 30 ft
Public Health	Tobacco free
Human Services	Outside the employee entrance door and 15 feet away from the door. The door must be closed if people are outside smoking.
Sheriff's Office	15 feet from Sheriff's Office private entrance (West Side)
Library	Library Parking Lot
Community Center/CSU extension office	North side of parking lot
Public Works Building	North side of the shop
Solid Waste	Southeast end of the building
Courthouse in Central City	Side parking lot – 100ft from the entrance, 50 ft from the windows
Ballfield	Big field – side of the ballfield shed adjacent to the outhouse and facing away from the fields. Little field – Ballfield parking lot
Jail	INMATES ONLY – Jail issued e-cigarettes in their assigned cell
